OUTAGE PURPOSE: UH Electrical Department will be perform emergency generator and building life safety systems testing. This testing is required to ensure that the systems are functioning properly for building occupancy.

IMPACT MESSAGE: Only building equipment and systems that are on the emergency backup power in the buildings will be effected. The equipment will see (2) short 8 second loss of electricity at the start and end while the normal power is turned off, generator is activated and transfers the electricity over to the generator.
