OUTAGE PURPOSE: The purpose of the road closure is to allow the offloading a new fire pump motor. The fire pump will be brought onto campus using a tractor-trailer and offloaded using a front end loader.

IMPACT MESSAGE: The offloading of material will impact the ungated faculty/staff parking area between Engineering I (#579), and the Central Power Plant (#515). Access to and through the ungated faculty/staff parking area will be limited/restricted for approximately 2 hours to set up a crane and lift pump house into place. The users have approved.

Construction Contractor supplied flag men will be available to direct traffic and relieve traffic congestion and build-up.
