Robin Evans: Deputy Commissioner for Patents

As Deputy Commissioner for Patents, Ms. Evans manages and leads patent examining functions in Technology Centers (TCs) that examine a wide variety of technology including transportation, construction, agriculture, electronic commerce and national security, as well as biotechnology and organic chemistry arts. She also provides executive leadership to the quality related offices responsible for training, process improvement, quality statistics and stakeholder experience.

Ms. Evans began her career at the United States Patent and Trademark Office (USPTO) as a patent examiner focused on applications in the mechanical area. Ms. Evans was selected as the first Regional Manager of the first USPTO regional office located in Detroit, Michigan. Ms. Evans also served as the interim Director of the Rocky Mountain Regional Office in Denver, Colorado. Prior to her present role, Ms. Evans served as Acting Associate Commissioner for Patent Quality.

Ms. Evans serves as Executive Sponsor for a new Patents Business Unit (BU) Diversity, Equity and Inclusion (DEI) committee to foster an inclusive workplace where diversity and individual differences are valued and leveraged. In this role, Ms. Evans provides leadership and direction to focus on equity, fairness and community.

Carmen V. Lyles-Irving: Texas Regional Outreach Coordinator

As the Texas Regional Outreach Coordinator, Ms. Lyles-Irving is responsible for stakeholder engagement and outreach initiatives on behalf of the USPTO in the eight states that comprise the Texas Region: Alabama, Arkansas, Louisiana, Mississippi, New Mexico, Oklahoma, Tennessee, and Texas.

Ms. Lyles-Irving is a Primary Examiner under Technology Center 1700 specializing in prosecuting patent applications in the fields of Fuel Cells and Batteries. In addition to working as a Primary Examiner, she has detailed at the Patent Trial and Appeal Board and with the Office of Petitions. Ms. Lyles-Irving has served with the USPTO from July 2012 through September of 2022, before that Ms. Lyles-Irving worked as a Registered Patent Attorney where her practice involved patent preparation and prosecution as well as trademark preparation and prosecution.

Additionally, Ms. Lyles-Irving worked in chemical processing and product manufacturing as a Chemical Engineer prior to attending graduate school and law school.

Ms. Lyles-Irving has a BS in Chemical Engineering from Florida Agricultural and Mechanical University, a MBA from The University of Georgia, and a JD from The University of Georgia.
